

# AHAP Tax Credits for Qualified Donors



Life Unlimited has been approved for Affordable Housing Assistance Program (AHAP) Tax Credits for 2025-2026.

Up to \$4 million in eligible gifts supporting Life Unlimited's new housing campaign, The Trails, can receive AHAP tax credits (\$2.2 million in tax credits).

**Eligible donors will receive 55% of their donation back** as a Missouri state tax credit.

- Credits may be applied dollar-for-dollar against liability from Missouri taxes
- Credits can be used immediately or rolled forward up to 10 years without penalty, and are fully transferrable.

**Combined with Federal and State deductions, donors receiving AHAP tax credits can get up to 77% of their donation back in tax savings.**



## Eligibility

**Eligible Donors** must be subject to Missouri tax from business activities performed in the state of MO: a corporation; sole proprietorship; farm; individual reporting income from rental property or royalties; small business corporation; partnership; bank, credit institution, savings and loan association, credit union, etc.; insurance company; individual partner in a partnership or shareholder in an S-Corp; or a foundation.

**Eligible Donations** include cash, stock, real estate, professional services or in-kind goods and must be eligible for the federal income tax charitable deduction. *Gifts must be received by April 30, 2026.*

## Maximize Impact and Savings with AHAP Tax Credits

Sample of Estimated Tax Effect - 35% Tax Bracket		
	With AHAP Tax Credit	Without AHAP
<b>Donation Amount (cost to build one house):</b>	\$ 580,000	\$ 580,000
AHAP Tax Credit (55%):	\$ (319,000)	
Fed Inc Tax Charitable Donation Deduction (35% of reduced amount)	\$ (91,350)	\$ (203,000)
MO Inc Tax Charitable Donation Deduction (6% donation amount)	\$ (34,800)	\$ (34,800)
<b>Net Cost to Donor (to build one house):</b>	\$ 134,850	\$ 342,200
<b>Net Savings to Donor:</b>	\$ 445,150	\$ 237,800

**With AHAP, for every \$1 donated, donors can receive 77 cents back after credits and deductions.**

Without AHAP, for every \$1 donated, donors can receive 41 cents back with deductions alone.

\*Estimates assume itemization and 35% federal income tax bracket.
